## Terms & Conditions



1. All guests must be at a minimum of 5 months of age, de-sexed and with completed updated vaccinations. Dogs need to have a C5 vaccination given 5 days or greater before check in, however for best protection we recommend the Intranasal Bronchi-Shield 3 vaccination given 8 days or greater before check in. Dogs must be flea free.
2. Most dogs will be “companion boarding” matched according to size, age, gender and temperament unless requested or required to board alone.
3. Wagging Tails Rural Retreat reserves the right to refuse entry of any dog.
4. The owner agrees to be solely responsible for any and all acts or behaviour of the dog while it is in Wagging Tails Rural Retreat’s care.
5. The owner specifically represents that he or she is the sole owner of the dog, free and clear of all liens and encumbrances.
6. The dog will be delivered to any person who is able to declare that they have the owner’s authority to do so, unless otherwise instructed in writing by the owner upon boarding.
7. The owner understands that Wagging Tails Rural Retreat is not a veterinary medical facility and if veterinary attention is necessary for the dog, the owner is liable for all such expenses.
8. By signing the contract conditions, the owner certifies to the accuracy of all information given about the dog. The owner acknowledges that the signing of this contract shall create a lien over the animal in favour of Wagging Tails Rural Retreat, which lien shall continue to exist whilst ever monies are owing to contract.
9. Under no circumstances will Wagging Tails Rural Retreat, or it’s employees or agents, be held responsible for Paralysis Tick, Canine Influenza, injury, death, loss or damage of any kind whatsoever, whether or not caused by any negligent act or omission of Wagging Tails Rural Retreat, it’s employees or agents, that may occur to any pet staying at Wagging Tails Rural Retreat.
10. Playtime/Exercise: Wagging Tails Rural Retreat, it’s staff and agents will not be liable for any problems which develop, provided reasonable care and precautions are followed, and the client hereby releases them from any liability of any kind whatsoever arising from the dogs attendance and participation in this service.
11. The full period booked will be charged during school holiday periods.
12. Boarding rates are charged on a per night basis.
13. The owner agrees to pay the rate for boarding that is in effect on the date that the dog is checked into Wagging Tails Rural Retreat.
14. The owner agrees to pay all costs and charges for special services requested and all veterinary costs for the dog during the time the dog is in Wagging Tails Rural Retreat’s care.

15. All additional charges incurred by the owner will be processed on your credit card prior to departure unless other payment arrangements have been made.

16. If all charges are not paid, Wagging Tails Rural Retreat has the right to offer the dog for public sale. If such a sale does not secure a price adequate to cover the charges and the cost of sale, the owner is liable to Wagging Tails Rural Retreat for the difference.

Wagging Tails Rural Retreat may take this course of action if not advised of a pick up date within one (1) week of the advised dates.

### **Holiday periods**

15/12/ YEAR to 15/01/YEAR

Bookings beginning or ending during this period require a deposit of 50% of the total booking fee to be paid 2 weeks in advance of boarding commencement.

### **Payments**

Deposit (payable during holiday periods) = 50% of booking cost.

Balance of all bookings to be paid 30 days from date of invoice.

### **Cancellation Policy**

Cancellation within 48 hours (cooling off) – no fee charged.

Cancellation less than 2 week prior to arrival – deposit forfeited.

17) **Entire agreement** – This agreement (and the documents to which it refers) constitutes the entire agreement between the parties in respect to the Wagging Tails Rural Retreat and supersedes all other agreements, understandings and representations and negotiations with WTRR in relation to the WTRR boarding. To the extent that any clause of this agreement is void or unenforceable it is severable and does not affect the remaining provisions of the agreement.

18) **Statement of Understanding** – You have read, or have had read to you the above conditions and having understood the same, you consent to conditions regarding dog boarding and do so on the basis set out in this agreement.
